

Terms and Conditions for Maxim-AI.com

Introduction

- Maxim-AI.com ("the Website") is operated by MS Marketing/Max Gomberg, ("MS Marketing" or "Max Gomberg" or "the Company"). The Website serves as a sales platform for consulting, coaching, and training services in artificial intelligence, marketing, and advertising ("the Service" or "the Services" or "the Products").
- For convenience, these terms use masculine pronouns, but they apply equally to all genders.
- Purchases made through the Website are subject to the conditions detailed in these terms.
- By purchasing a Service on the Website, the customer declares that they have read, understood, and agreed to these terms. These terms constitute a binding contract between you and the Company.
- This policy is designed to explain how Max Gomberg, a sole proprietorship, collects, uses, and protects the personal information of its customers.

Purchasing

- The Website allows customers to conveniently and securely purchase the offered Services online.
- Services can be purchased at any time until they are sold out or the event date arrives.
- Purchases on the Website can be made using credit cards, PayPal, or other specified payment methods. Transactions will be processed after approval by the payment provider.
- Prices listed on the Website include all applicable taxes.
- The Company reserves the right to discontinue the marketing and sale of Services at any time and to revoke the right to purchase from the Website at its discretion.

Returns and Cancellations

- Transactions can be canceled by contacting the Company's customer service via phone or email. Cancellations will only be effective upon receipt of a confirmation email from the Company acknowledging the cancellation request.
- In the event of a cancellation, the customer will receive a refund based on the following conditions:
 - For cancellations made up to one week before the Service date specified at the time of purchase, the Company will provide a full refund.
 - For cancellations made between one week and 48 hours before the specified Service date, the Company will provide a 50% refund of the transaction amount.
 - No refund or credit will be given for cancellations made 48 hours or less before the specified Service date.
- The above cancellation policy applies only to Services and/or Products purchased through the Website. The Company will not process returns for Services and/or Products purchased through other channels.
